**WHEREAS** the *Canadian Charter of Rights and Freedoms* guarantees the right to equal protection and equal benefit of the law without discrimination based on religion and other grounds (section 15), and also guarantees freedom of religion (section 2(a));

**WHEREAS** the Canadian Bar Association is opposed to all forms of religious discrimination in the legal profession and otherwise;

**WHEREAS** lawyers from diverse religious communities have made and continue to make important contributions to the legal profession and cause of justice in Canada;

**WHEREAS** the CBA recognizes that the administration of justice is enriched by the equal and full participation of religious lawyers without discrimination;

**BE IT RESOLVED THAT** the CBA:

- affirm its commitment to religious equality and diversity, and to combatting any religious discrimination within the legal
