- 1. Meeting called to Order and Land Acknowledgment President, Reché McKeague, Q.C.
- 2. Welcome by Reché McKeague, Q.C. to those in-person and those attending online.
- Approval of Consent Agenda
 MOVED and SECONDED that the Consent Agenda Items be approved. CARRIED

4. Greetings:

Honourable Bronwyn Eyre, Minister of Justice and Attorney General of Saskatchewan brought greetings on behalf of the Government of Saskatchewan, Ministry of Justice.

Stephen Rotstein, CBA President, brought greetings on behalf of The Canadian Bar Association.

5. President's Report:
