# 1. Call to Order

The Annual Meeting was called to order by President David Thera, QC. Dave welcomed everyone and thanked them for coming.

# 2. Approval of Agenda

Motion by Perry Erhardt, QC, seconded by Michelle Ouellette, QC, that the agenda be approved as circulated. Carried.

# 3. Minutes

Motion by Kylie Head, seconded by Neil Robertson, QC, that the minutes of the Annual Meeting on June 23, 2011 in Regina be approved as circulated. Carried.

# 4. Greetings from the Law Society of Saskatchewan

Law Society President Greg Walen, QC brought greetings on behalf of the Society. Greg reported that the CBA and the Law Society Executive had met earlier over lunch to discuss issues of mutual concern. He noted that while each organization has a distinct mandate, we have a great relationship and work together in a number of areas.

# 5. President's Report

Dave noted that his written report was available in the Annual Report available on line.

The CBA's Legal Aid Liaison Committee created a new award to recognize legal aid lawyers who have made a significant contribution to providing access to justice to people in need. The Legal Aid Leader Award aims to: promote, reward and recognize outstanding contributions to access to justice through legal aid; encourage lawyers to contribute to providing legal aid services; raise awareness of the important role lawyers play in delivering legal aid services. Amanda Dodge of CLASSIC was the first recipient of this award. Dave presented Amanda with the award.

Dave thanked Perry for his service and commitment to the CBA over the last number of years and presented him with a token of appreciation on behalf of the Branch.

# 6. Vice-President's Report

Heather MacMillan-Brown advised that her written report was available in the Annual Report available on line. Heather reported that she was looking forward to next year and noted that next year both Presidents of the Law Society and the CBA would be women – and both Heather (referring to Law Society Vice-President Heather Laing who will serve as President beginning January 1, 2013).

### 7. Past President's Report

Perry noted that his written report was available in the Annual Report available on line.

### 8. Nominating Committee Report

Perry noted that the Nominating Committee report was available in the Annual Report available on line prior to the meeting. He advised that most positions were filled and thanked the many volunteers for stepping forward when asked. Perry moved adoption of his report; Jenn Pereira seconded the motion. Carried. Perry invited members to contact either him or Brenda Hesje if they are interested in filling one of the vacant positions.

### 9. Treasurer's Report

Kylie Head noted that her written report was available in the Annual Report available on line. The financial statements for the period ending April 30<sup>th</sup>, 2012 were circulated with the meeting materials. Kylie advised that we are ahead of budget and that she anticipates ending the year that way despite a budgeted deficit. She reported that the budget for 2012-2013 was approved at the May 2012 Council meeting – the budget again is set with the intention of drawing down the reserves.

### 10. Communications Report

Kaylea Dunn noted that her written report was available in the Annual Report available on line.

### 11. Legislation and Law Reform Report

Lora Bansley reported that she had taken on the LLR position four months ago and has been very busy. She has been contacting the Section Chairs and inviting people to contact her with any issues. Lora advised that her written report was available in the Annual Report on line.

#### 12. Membership Report

Gail Wartman reported that membership numbers continue to rise in Saskatchewan – unlike a number of other jurisdictions. She advised that her written report is available in the Annual Report on line.

#### 13. Professional Development Report

No report available.

#### 14. Professional Image Report

Jenn Pereira noted that her written report was available in the Annual Report available on line.

#### 15. Membership Fee Review

Michelle Ouellette, QC reported that after 18 months of research and study, the Fee Review Working Group brought its recommendations for a new fee structure to the Board of Directors for approval at their June 2012 board meeting.

What began as a study of membership dues evolved into a detailed review of the way CBA delivers value to members. It involved segmentation of our membership and identification of the specific needs of groups, and a thorough assessment of pricing categories and price points.

Three principles guided the work of the Group.

The new model would have to encourage:

- > Revenue growth or have neutral impact on revenues;
- > Membership growth or have neutral impact on membership levels;
- Member participation.

The recommended fee model brings a fundamental change to CBA's membership philosophy. From a static, "one size fits all" approach based on year of call, it recommends a philosophy of choice and value. The focus is on the member defining their own value, and the CBA offering responsive fee alternatives.

The new CBA Fee Structure has three elements:

- Individual Pricing available to all members of the Association, allows for enhanced preferential pricing the more a member is engaged.
- Special Circumstances Pricing available to members of the Association who meet specific definitions for categories that allow for specific price reductions.
- Group Pricing available to members of the Association who work in organizations that have 50 or more lawyers. The model recognizes the size of these organizations.

The recommended model creates a new and exciting approach to fees.

- Three (3) options for firms;
- One (1) option for new lawyers;
- > Two to three (2-3) new special circumstance categories;
- > Three (3) options for individuals.

As a whole, this recommended model is modern, responsive, responsible, smart and member focused.

The Membership Committee endorsed the model and, with the Fee Review Working Group, recommended it to the Board of Directors for approval. The CBA Board of Directors have recommended it to Council. It will be dealt with at Council in Vancouver this August.

#### 16. Other Business

There was no other business.

#### 17. Saskatchewan Courts Report

Chief Justice J. Klebuc (Court of Appeal), Chief Justice M. Popescul (Court of Queen's Bench) and Chief Judge C. Snell (Provincial Court) reported on the activities of their respective courts. Dave thanked the judges for their reports and continuing support for the CBA.

The meeting adjourned.

# **PRESIDENT'S REPORT** Heather MacMillan-Brown, Q.C.



It has been a whirlwind of activity since I stepped into the role of Branch President on September 1, 2012. Our CBA year starts with a few key events involving College of Law students.

First was our wine and cheese reception at the College, where students got to meet the Executive and other CBA members and buy their student memberships.

Our next event was the CBA "Meet Your Match" Reception at Winston's Pub in Saskatoon. Each year, CBA members from across the Province

volunteer to become a mentor to a College of Law student. These relationships often last beyond the year and, indeed, beyond the student's time at the College of Law. This year, over 100 students were paired with lawyers through the mentorship program.

I also attended the CBA Saskatchewan Law Firm Showcase, at which Saskatchewan law firms set up shop at the College of Law to introduce themselves to students in order to persuade them of the merits of practicing in Saskatchewan after graduation. The CBA works with the College of Law to make this showcase the success that it has become since its inception several years ago.

In January, the Branch organized a Mock Interview event at the College. CBA volunteers spent the afternoon at the College, interviewing and reviewing student cover letters and resumes. This year the number of students participating was down, with 26 students registered for two sessions each.

Through these events, the Branch works to foster a relationship with both the College of Law and its students. It is important to promote the values of becoming a CBA member to students at the College of Law in hopes that the benefits of CBA membership will be an incentive for the students to not only maintain their CBA membership but to also become actively involved in CBA in their future careers.

In November, I hosted the annual President's Dinner in Regina and presented Past President David Thera, Q.C., with a pin to recognize his past and continuing contributions to the CBA. It was a fun night as the Past-Presidents shared stories about their time as President.

In the budget for 2012-2013, the Branch had allocated funds to hire a Communications Officer. Kayla Stuckart started in early 2013 and has been a fantastic addition to the Branch Office team. With her guidance, CBA Saskatchewan entered the realm of social media and now has a Facebook page and is on Twitter. We will also be rolling out a new website in the Fall.

At the end of January, I attended the Alberta Legal Conference and brought greetings at their Council Meeting.

In February of 2013, I co-chaired and attended the CBA Saskatchewan Mid-Winter Meeting. As always, the MWM offered a wide range of CPD topics and speakers.

In February of 2013, I attended the National Mid-Winter Meeting in Mont Tremblant. This included attending the National Board of Directors meeting and attending the meeting of the full National Council.

I attended our annual Branch Planning Meeting in Regina. At the meeting, which was chaired by Vice-President Kylie Head, our budget for 2013-2014 was drafted and approved by the Executive, to be put before Council at the following Council meeting in April of 2013. In addition, a draft of our new Strategic Plan for the Saskatchewan Branch was finalized to be put before Council for approval. At our April Council Meeting, both the budget and the Strategic Plan were approved unanimously.

I attended various Law Day events including the Mock Trial and the Law Day Luncheon, featuring Dr. Samantha Nutt. I quite sheepishly admit that I did not run in the Law Day Fun Run but I really didn't want to put other runners at risk of having to perform CPR. We also ran our first Law Day Essay Contest for Grade 7-8 students this year and were pleased with the interest expressed.

On June 7, 2013, I will be travelling to Ottawa to attend the National Board of Directors meeting. The national meetings are always a wonderful opportunity to meet with the Presidents from other provinces and territories. It is interesting to note how many issues are common to Branches across the country. The highlight of my time in Ottawa will, I'm sure, be the annual dinner with the Supreme Court of Canada. The Branch Presidents and the National Executive have the privilege of dining with the Supreme Court Justices in their private dining room at the Supreme Court.

Our Branch Annual Meeting is planned for June 20<sup>th</sup>, in conjunction with the Law Society Annual Meeting dinner. We will be hearing from the three Chief Judges, who will provide their annual report to the members, as well as presenting our Community Service Award.

Perhaps the most exciting part of my presidential year will be the CBA Canadian Legal Conference in August of 2013. In just over two months, Saskatoon will play host to CBA members from across the country. I am a member of the CLC Planning Committee, co-chaired by Michelle Ouellette, who continues to demonstrate her longstanding dedication to the CBA, and Robert Kirkpatrick.

It goes without saying that the Branch would not function without the invaluable assistance provided by Executive Director, Brenda Hesje. Thank you to Brenda for continuing to lend her experience to the members of the Executive and CBA members from across the province.

In sum, my year as President and my role on the Branch Executive served to remind me of the value of becoming involved with the CBA, both at a provincial and at a national level. The Branch, and particularly the Executive of CBA Saskatchewan, is made up of some exceptional and dedicated individuals who contribute their time and energy to this organization. # VICE PRESIDENT'S REPORT Kylie Head



I am pleased to report to the CBA Saskatchewan Branch on a very engaging year from September 1, 2012 until now in my role as Vice-President. This report is a summary of my volunteer service on behalf of the CBA, during my year as Vice President.

Throughout the year, I attended the Branch Executive Committee and Council meetings. I also served as a member of the National CBA Public Sector Lawyers Forum Executive Committee. I was invited to join this committee after attending the CLC in Vancouver in 2012 and meeting the past president of the Public Sector Lawyers Forum.

My continued involvement with the Executive Committee included: monthly national conference calls; attended in-person executive committee meeting in Ottawa on December 1, 2012; presenting the committee's verbal report to Council at the National Mid-Winter Meeting in February 2013 and represented the Committee at the national Conference Chairs meeting; helping to organize the Ethics CPD session that will be hosted by the PSLF at the CLC in Saskatoon; planning of the John Tait Award of Excellence reception; planning to organize a conference call brown bag lunch in the spring; and arranging how we want to maximize our use of free/low cost online professional development in this time of fiscal restraint for governments in Canada.

I served as a member of the National CBA Equality Committee. My duties on this committee included: attending conference call meetings (varying from one to three per month) and two in person meetings (Ottawa on October 28 and 29, 2012, and an upcoming meeting at the CLC in Saskatoon); presenting the committee's verbal report to Council at the National Mid Winter Meeting in February 2013; helping to organize the half day CPD session that will be hosted by the Equality Committee at the CLC in Saskatoon; working with National to collect demographic data to help us understand our membership (please add your demographic info to your member profile); finalizing *The Touchstones Newsletter* that the Committee published in 2013, dealing with the theme of physical and mental disability; focusing on increasing diversity in the CBA leadership; evaluating the Equality Committee's <u>Measuring Diversity Guide</u> (for tips on equality and inclusion, check out the Equality Committee's <u>YouTube diversity videos</u>); circulating the <u>RARE Finds</u> Project, which provides resources for lawyers and law firm leaders on issues relating to attrition, advancement and re-entry into the legal profession for members of historically marginalized groups, as well as an inspiring showcase of CBA member success.

I spoke on a panel about hopes and challenges for next generations of lawyers, including emphasis on the CBA issue of retaining women in the profession, at the Future of Law Conference at the University of Saskatchewan on November 1 and 2, 2012. This Conference was part of the College's centennial celebrations.

I attended the Past Presidents Dinner November 14, 2012.

I served as the Branch representative on the 2013 Lawyers' Gown to Gown Charity Gala Organizing Committee, raising money for Pro Bono Law Saskatchewan. My duties on this

committee included: attended planning meetings, roughly once per month; determining the date of Gala (January 25, 2013 at the Hotel Saskatchewan); and planning preperations of the event. 159 tickets sold, with musical entertainment provided by the Jack Semple Band. Mr. Justice Richards served as MC. Stephanie Yang received the 2012 Pro Bono Service Award. The Silent Auction raised \$6,200. In addition, the CBA donated \$2,500, LSS donated \$1,500, the College of Law donated \$1,500, and MNP donated \$2,000. The total amount raised after all expenses was \$25,511.93, which is an increase from the last time Regina hosted.

I attended the 2013 Branch Mid-Winter Meeting in Saskatoon in February 2013. Our 2014 Mid-Winter Planning Committee, chaired by Jordan Hardy of MLT, has begun its work.

I attended the National Mid-Winter Meeting in Mt. Tremblant, February 14 to 17, 2013, including the following other meetings: Council meetings; National Board Meeting as Vice President (Observer); the National Conference Chairs meeting, representing the Public Sector Lawyer Forum Chair who could not attend; and I provided the verbal reports to Council on behalf of both the Equality Committee and the Public Sector Lawyers Forum, since the Chairs were not able to attend.

I chaired the Executive Committee Planning Meeting on March 15 and 16, 2013. This was the first year that the planning meeting was more than one day long. Among other discussions, we developed the new Strategic Plan for the Branch.

I helped organize and acted as MC at the Regina Law Day Luncheon, with Dr. Samantha Nutt on April 23, 2013.

I provided orientation to incoming Section Chairs in Regina on April 25, 2013 and in Saskatoon on April 29, 2013.

On June 7, 2013 I will attend an orientation session at the CBA National Office in Ottawa for incoming Branch Presidents. This is a great opportunity to meet with the senior management and staff at the National Office and learn about the valuable contributions they make to the organization and our profession. It is also a chance to meet the incoming Branch Presidents from across the country and compare notes. I will also attend the Board of Directors meeting on June 8 and 9.

I will attend the CLC in Saskatoon in August, 2013, including the following additional national business meetings: Equality Committee Meeting; Public Lawyers Sector Forum Meeting; and CBA National Board Meeting.

It was a productive, educational and enjoyable year and I look forward to continuing to serve on the Branch Executive Committee next year.

# TREASURER'S REPORT Gail Wartman



The financial position of the Saskatchewan Branch of the Canadian Bar Association continues to be sound. Our annual review engagement of our accounting practices produced a satisfactory result.

The approved budget of \$571,900 for the period September 1, 2012 to August 31, 2013 projected a deficit of \$186,600, to be drawn from reserves.

As at the end of April, 2013, eight months through the year, 52.6% of projected expenditures had been made. Revenues at this point in the

year are \$311,553.98, and we forecast that revenues will be close to our budgeted amounts of \$385,300 (before amount drawn from reserves).

I confirm that our Branch operating reserve is currently \$278,550, which satisfies the guidelines for reserves set by both the CBA National office and our Bylaw requirements.

# PAST PRESIDENT'S REPORT David Thera, QC



During my final year on the Executive of the Saskatchewan Branch, I have enjoyed the opportunity to represent our members at events and programs held in conjunction with the University of Saskatchewan, College of Law, including the September Wine and Cheese Reception, participating in the CBA Mentorship Program and speaking at the Law Firm Showcase. In addition to events throughout the year, we continue to sponsor scholarship opportunities. # LEGISLATION AND LAW REFORM COMMITTEE Lora Bansley, Chair



Advocacy with respect to legislation and law reform is a key and vital component of the CBA. This past year has been a busy one for Legislation and Law Reform.

The role of the Legislation and Law Reform (L&LR) Chair is to monitor, coordinate and assist with the preparation and presentation of Branch submissions on any matter respecting government initiatives made by Sections, Committees and the Branch Executive. Each CBA section designates a L&LR representative for their Section. Proposed legislation that is introduced by the government and calls for consultation are

circulated to the Section Chair and LR&R Representative for review and comment. Reports and papers from the Law Reform Commission are also forwarded to the appropriate sections.

This past year I have been researching how the CBA in other provinces handle their legislation and law reform portfolio and will be working on creating new documentation for Saskatchewan's process. The CBA SK will be launching a new website and as part of that process will be implementing a new Advocacy section where formal CBA submissions will be posted along with the response received.

The CBA Saskatchewan made three formal submissions to government in this past year:

- 1. Sent a letter to the Minister of Justice regarding amendments to The Small Claims Act, 1997 granting Justices of the Peace authority to hear Small Claims matter. The Minister of Justice responded in August 2012 advising that the Ministry shares the CBA's view that it is important to have individuals in place who are legally trained and have civil litigation and mediation experience. He confirmed that the Court requires that senior Justices of the Peace who are assigned Small Claims Court responsibilities have legal training.
- 2. The CBA provided two formal submissions regarding new legislation pertaining to Foreign Worker Recruitment and Immigration Services. The CBA opposed the inclusion of lawyers in the licensing and oversight provisions of the legislation stating the provisions conflict with the self-regulating nature of the law profession under the Law Society of Saskatchewan. The Bill exempts members in good standing of provincial law societies from the requirement to be licensed by the province when providing immigration services. However, lawyers were not exempted from the recruitment services portions.

The CBA supported a submission by the Immigration Sections opposing this and expressing concern that the definition of "recruitment services" is overly broad. The concern was that the definition would cause all immigration lawyers to require licensing as the practice of immigration law almost invariably involves assisting or advising "a foreign national or an employer to secure employment for a foreign national in

Saskatchewan." In response to our correspondence to the Ministry of the Economy in relation to the proposed *Foreign Worker Recruitment and Immigration Services Act*, we have been advised that while they do not intend to regulate lawyers in the practice of law, lawyers that provide "recruitment services" will continue to be included under this legislation.

3. A letter was sent by the CBA to the Minister of Justice supporting a request by the Taxation Law South Section for an amendment to *The Business Corporations Act*, regarding the Stock Dividend Freeze provisions. The Minister responded indicating that he has directed his officials in the Ministry of Justice to include the request in their review of the proposed changes, advising that the next amendment to The Business Corporations Act would most likely proceed in the Fall of 2014.

The Law Reform Commission of Saskatchewan released a number of consultation papers and final reports this past year, which are forwarded to the appropriate sections. Examples of these are the *Presumption of Crown Immunity: Consultation Paper*. It discusses the presumption of Crown immunity and the consequences of removing it. I distributed this to the Civil Litigation, Business Law, and Public Sector & Municipal Law sections. They also released a *Reform of The Land Contracts (Actions) Act: Consultation Paper*. This was circulated to the Real Property and Wills South and the Bankruptcy & Insolvency Sections.

# MEMBERSHIP COMMITTEE

Loreley Berra, Chair



As of May 27, 2013 the CBA's membership was 38,226 active members with 37,452 paid and 774 unpaid. This represents an increase of 361 active members from the same time last year. The current number of unpaid members is 774 and represents only 2% of our active members.

As of May 27, 2013 CBA Saskatchewan Branch membership was 1,150 active members, with 1,140 paid and 10 upaid. Branch membership continues to grow in a year-over-year comparison with

an increase of 54 members (4.97%) over May 27, 2012.

The good news is that the majority of CBA Branches saw membership growth in the May 2013 year-over-year comparison. Prince Edward Island, Saskatchewan, and Nova Scotia continue to experience notable growth and only two CBA Branches saw a very small decline in membership numbers in the year-over-year comparison. Nationally, the CBA member numbers continue to increase in a year-over-year comparison; 319 (0.86%) greater than in May 2012.

Of the 37,452 paid members of the Canadian Bar Association, 4,412 are Regular CCCA members; almost 12% of the CBA's total paid members, are members of the CCCA. We are very pleased to report that as a result of considerable hard work by CCCA Executive, Members and Staff, the number of Regular Members has increased by 118 from the same time last year.

# New Fee Structure

Over the last two years the CBA has been working to review its membership offerings and related fee structure. It conducted extensive consultations with members and listened to their views. It responded by strengthening the membership model to emphasize *choice*, *value* and *engagement*.

Recognizing that members have different interests and priorities, the redeveloped CBA membership model not only allows members to identify the benefits most important to them, but it also rewards commitment to the CBA, through savings opportunities. Changes to the CBA membership structure are part of the CBA's ongoing efforts to foster a stronger relationship with its members and provide smart, modern, responsive, and responsible services.

While membership fees remain unchanged – except for the CPI increase required each year by CBA's Bylaws – there are new choices for members' consideration.

- Greater choice and value for membership fees by rewarding increased engagement in the CBA. CBA members are now being offered <u>two</u> new options that can be purchased in addition to their CBA membership Portfolio and Portfolio Plus. These options offer members a savings of 20 25% on CBA Professional Development and Education activities, and Sections involvement, included in the options. Beginning in July 2013, the new options can be purchased at any time during the membership year. It is also important to know that members can simply renew their CBA membership as they did before, without choosing one of the new options.
- Increased access to CBA membership for more lawyers. The CBA recognizes that lawyers do not belong in a one-size fits all membership. The CBA is introducing two new membership categories part-time and non-practicing lawyers. For a 50% reduction in the membership fee, part-time and non-practicing lawyers can enjoy all of the benefits CBA membership has to offer. Eligibility for part-time and non-practicing status is determined provincial/territorial law societies.
- New discounts for New Lawyers (for the first three years following their call to the bar) and Articling and Bar Admission Students. For Articling and Bar Admission students, the CBA will offer a full membership at 75% off the membership fee. For a 60% reduction in the membership fee, New Lawyers can enjoy all the benefits of CBA membership.
- Membership renewal dates are changing. The CBA National Council has approved a change to the operative dates of annual membership in the CBA from a revolving membership year to a fixed membership year. The renewal date for all members will be September 1 each year. For those members who currently renew their annual membership on a date other than September 1, CBA will be offering payment options to facilitate the introduction of this change.

- A \$250 education credit, at a 20% discount a \$50 saving that can be applied to education products, services and activities from CBA National, CBA Branches and CCCA, for the term of your membership year.
- Section enrollment the number and level of included Sections depends on your provincial or territorial branch offering.
- A rebate off your next year's membership fee invoice, equivalent to 3% of your total spend outside of membership fees and the option purchased, from the previous year.
- Access to many CBA resources including special publications and tools.

# "Portfolio Plus" Option

Includes all benefits enjoyed by members plus:

- A \$500 education credit, at a 20% discount a \$100 saving that can be applied to education products, services and activities from CBA National, CBA Branches and CCCA for the term of your membership year.
- An increased number of Section enrollments the number of Section enrollments depends on your provincial or territorial branch offering (visit www.cba.org/membership for details).
- A rebate off your next year's membership invoice, equivalent to 5% of your total spend outside of membership fees and options purchased, from the previous year.
- Increased access to CBA resources including special publications and tools.

The Meeting's presentations were provided by a total of 58 speakers from across North America. The Meeting kicked off Thursday morning with distinguished keynote speaker, former Supreme Court of Canada Justice Ian Binnie, speaking to ethics and civic responsibility. On Friday morning, we received annual updates from Justice Minister Gord Wyant, QC and College of Law Dean Sanjeev Anand, QC, and enjoyed a dynamic presentation on mentorship by Betty Ann Heggie. Also on Friday, the Distinguished Service Luncheon was equally entertaining and touching, due to the presentations of Dan Shapiro, QC, and the worthy award recipient himself, Mark Brayford, QC.

The CBA SK Pro Bono Committee continued to work to facilitate and promote pro bono work in a variety of ways over the past year. A brief summary of these activities follows:

# BARNOTES Articles

A Pro Bono Spotlight piece is regularly submitted for publication in *BARNOTES*. The idea behind this column is to promote pro bono work within the province and also to provide information and resources to lawyers engaged in providing pro bono services.

# 4<sup>th</sup> National Pro Bono Conference & CBA Envisioning Equal Justice Conference

The Committee Chair attended and presented at the 4<sup>th</sup> National Pro Bono Conference in Montreal in the fall of 2012 and attended the Canadian Bar Association Envisioning Equal Justice Conference in April, 2013. The Conferences allowed for members of the national pro bono and legal aid community to gather in one location, network, and share ideas about improving access to justice in Canada.

# 5<sup>th</sup> National Pro Bono Conference

The Committee Chair is currently looking into the possibility of hosting the 5<sup>th</sup> National Pro Bono Conference in Saskatchewan in 2014. This event will allow Saskatchewan to show case the access to justice initiatives which are occurring in our province.

# National Pro Bono Committee

The Committee Chair continues to be involved with the National Pro Bono Committee. Currently the committee is involved in initiatives to reduce barriers to pro bono delivery nationwide such as the lack of insurance for some lawyers in certain jurisdictions.

The Committee Chair is pleased with the progress seen in promoting access to justice issues and the need for pro bono services over the past year in Saskatchewan. Pro Bono Law Saskatchewan has seen a steady increase of volunteers from Saskatchewan lawyers, which allows Pro Bono Law Saskatchewan to serve more clients each year. Thank you to the lawyers who volunteer their time as well as to the CBA Saskatchewan for the financial assistance it provides the disbursement fund, which covers out of pocket expenses for lawyers taking on pro bono files.

# 9<sup>th</sup> Annual CBA Law Firm Showcase

The 9<sup>th</sup> Annual CBA Law Firm Showcase was held at the University of Saskatchewan, College of Law on November 21, 2012. Eighteen law firms and other legal employers participated in a trade-show type event in the college's library.

The Showcase included small group discussions where students could hear from practitioners on various topics such as rural practice, public practice, in-house corporate counsel, large urban practice and small urban practice. The event was followed by a reception hosted by the LSA and the College of Law.

# Aboriginal Summer Student Hiring Program

The CBA continued to co-ordinate the Aboriginal Law Student Summer Job Program now in its ninth year. The purposes of the program are:

- (a) to allow law firms and the legal profession to gain greater insight into Aboriginal culture and issues;
- (b) to provide an opportunity for Aboriginal law students early in their legal career to obtain work experience in a law firm; and
- (c) to foster opportunities for ongoing relationships to develop between the Aboriginal students and practicing lawyers.

Participation was markedly down this year –with just CLASSIC, Saskatchewan Justice, the Law Society of Saskatchewan, and Robertson Stromberg LLP participating. No students found a job this year through the program.

Participation was down due to firms making hiring decisions earlier in the year. Rather than a January deadline, the CBA will need to consider an October deadline so as to be more competitive.

# Law Day

The CBA celebrated the 31<sup>st</sup> anniversary of the implementation of the Charter of Rights and Freedoms by hosting its annual Law Day Luncheons in Saskatoon and Regina on April 16 and 17, 2012. Dr. Samantha was the guest speaker whose speech, "Why the World Needs More Lawyers" was inspiring. Dr. Nutt, is an award-winning humanitarian, and a leading authority on the impact of war on civilians.

# Pilot High-School Outreach Pilot Project with PLEA & PBSC

In conjunction with PLEA and PBSC, the CBA participated in a high school outreach program where a law professor, law student and practicing lawyer made joint presentations to Law 30 classes at 5 high schools in Saskatoon. The positive feedback from teachers and students was overwhelming and the intention is to expand the program across Saskatchewan in the coming year.

# QUEEN'S COUNSEL COMMITTEE

David Thera, QC, Chair

The designation of Queen's Counsel is made by the Minister of Justice through a selection process that includes consultation with the Canadian Bar Association, the Law Society of Saskatchewan and the Courts. The CBA Queen's Counsel Nominating Committee was chaired by me and comprised of Branch President Heather MacMillan-Brown, QC, and Past President, Perry Erhardt, QC.

The selection of nominees for the designation of Queen's Counsel is based upon the following criteria:

- Demonstrated superior legal ability;
- Proof of good character and integrity; and
- No person shall be appointed who has not been entitled during ten years to practise in the superior courts of the United Kingdom of Great Britain and Ireland or of any province or Territory of Canada or for a portion of such period in one and for the remaining portion of such period in another or others of the said courts.

The selection of the CBA's nominees has further qualifications. A CBA nominee must be a member of the Canadian Bar Association. The CBA also considers the following criteria, each of equal weight:

- Contributions as a legal professional to the community;
- Contributions to the community generally; and
- Contributions to the legal profession, with an emphasis on contribution to the Canadian Bar Association.

The CBA will also, in its recommendations, take into account considerations of gender, diversity and geography.

The CBA now uses its own Queen's Council Application/ Nomination form which is available on the <u>CBA website</u>. The CBA QC Committee met in mid-October to determine its nominees prior to the meeting with the Minister of Justice, the Law Society and the Courts on October 29th.

The recipients of the QC designation were announced in mid-December.

#### RESOLUTIONS, CONSTITUTION & BYLAWS COMMITTEE Robert Thornton, QC, Chair

Since the last Annual Meeting of the Branch the following resolutions or motions, other than customary motions, have been passed by Branch Council:

- (a) On November 15, 2012, Council approved establishment of a Branch Section of the Sexual Orientation and Gender Identity Conference;
- (b) On February 7, 2013, the Branch appointed David Gerecke to establish and chair a working group to prepare and present the Branch position on legislation concerning ISC privatization;
- (c) On April 25, 2013, Branch Council approved the CBA Saskatchewan 2013-2015 Strategic Plan as circulated to Branch Council.

There have been no other resolutions or motions passed by Branch Council during the Branch year of 2012-2013 other than customary motions approving Council meeting agendas and minutes, accepting reports, and passing the Branch budget.

There are presently no proposed amendments to the Branch Bylaws. The last amendments to the Bylaws were made at the Annual Meeting of the Branch held on June 17, 2010.

# ABORIGINAL LAW NORTH

# ABORIGINAL LAW SOUTH

The Aboriginal Law South Section continues to improve its presence and is looking forward to continuing this momentum into the 2013/14 year.

This past year the South Section held five luncheon meetings. The goal of the South Section was to present a topic agenda that was balanced and emphasized both the practical and academic. The 2012/13 topics included:

- 1. Treaty Land Entitlement Update: This presentation saw the Lands and Consultation Branch from the Ministry of Government Relations present on the provincial implementation of the TLE Framework Agreement. This session was well attended and attendees engaged in good discussion on the topic.

- The Environmental Assessment Amendment Act, 2010

Saskatchewan's *Environmental Assessment Act, 2010* was proclaimed in November 2012. The government's stated intention regarding the amendments is to "support the government's growth plan by increasing legal certainty for project developers, promoting greater efficiencies in the environmental assessment process, and modernizing offence and penalty provisions." (See Government of Saskatchewan News Release, November 7, 2012).

The most notable changes include:

- The ability of a proponent to apply to the Minister for a determination (and not an opinion) as to whether a project constitutes a "development" and a 10 day limitation on the written notification of that determination;
- The Minister is now empowered to determine the scope of assessments and content of the statements for developments and classes of developments as well as procedures and methods for conducting assessments and preparing statements; and
- The penalty provisions include increased fines (e.g., from \$5000 to \$500,000), the possibility of imprisonment and the possibility for summary conviction of knowing directors, officers and agents.

• <u>The Forestry Professions Act</u>

Amendments to the Act made on May 15 now require anyone practicing professional forestry on forest Crown lands to be registered with the Association of Saskatchewan Forestry Professionals (ASFP). The ASFP is professional association, similar to other professions like engineers, which serve to sustain high standards for its members in the practice of forestry. This means that the forests of Saskatchewan will be protected by qualified professionals, which will ensure the protection of forests into the future.

<u>The Fisheries Regulations</u> (under The Fisheries Act (Saskatchewan), 1994)
The Fisheries Regulations were recently amended in order to reduce tape around for most competitive fishing events, while still continuing to protect fishing in Saskatchewan. The amendments serve two purposes: (1) to streamline or eliminate the licensing requirement for most individuals and organizations as long as they comply with standard requirements, and (2) to provide additional protection to species of fish vulnerable to disease.

• Multi-Material Recycling Program

The new Multi-Material Recycling Program (MMRP) is a province wide which seeks to recycle items such as household printed paper, newspaper, cardboard, plastic, metal and glass packaging material in an effort to reduce these recyclables from ending up in landfills. "It is estimated that a MMRP will help to reduce the amount of household waste entering landfills by 40 per cent, which is equivalent to 52,700 pick-up trucks," (See Government of Saskatchewan News Release, May 21, 2013).

## FAMILY LAW NORTH

This was Gwen's last year serving as Chair. Tammi Hackl served as Vice Chair for the 2012 – 2113 year and as of June 1, 2013 will be Chair. The Section is presently taking nominations for Vice-Chair which it will continue to do every 2 years. Members have been invited to tender their application or nomination for the Vice Chair position by Thursday, May 31, 2013 with an email ballot to follow, if necessary.

#### Section Activities:

In the past year we hosted six luncheon meetings between September 2012 and April 2013. We started the fall with the Executive Director of the Law Society to discuss our new Code of Conduct and to remind us of common complaints made against family lawyers and how to avoid them. The second meeting was a joint meeting with the ADR Section. At that meeting, Gwen Goebel and Connie den Hollander (Chair of the ADR Section) discussed new provincial legislation and the initiatives taken by the board of the Collaborative Lawyers of Saskatchewan to prepare and promote an amendment to the Queen's Bench Rules and Forms with a view to ensure that family law clients are provided with meaningful and accurate information about ADR options.

Additional meetings covered substantive issues related to bankruptcy (Anne Hardy) and stock options (Brent Barilla). We also hosted an accountant (Keith Thomson) who often appears as an expert in family law matters to provide a refresher on calculating income where the payor is a farmer. We also had the benefit of hearing from Justice Neil Turcotte, a former member of our Section who currently sits on the Court of Queen's Bench Family Law Division. He provided a very candid and interesting perspective from the "New Kid on the Bench".

Plans are underway for the next year. We have six luncheon meetings arranged between September, 2012 and April, 2013. To date these include a practical lesson on how to use child support date bases effectively (Sherry Fitzsimmons), a discussion on the interplay between Child and Family Services and *The Children's Law Act* applications (Sheri Woods), and the a case review of *L.M.P. v. L.S.* 2011 SCC 64 and its impact on spousal support agreements. In the spring, we will provide an update on The Spousal Advisory Guidelines (Brent Barilla) as well as a practical session on "Tips for Dealing with Self Represented Litigants" from Kelly Shaw with Legal Aid Saskatchewan. We are also planning a joint meeting with the ADR Section on the High Conflict Mediation Project and, if possible, hope to host a Justice of the Family Law Division to address the impact of the new rules on family practice.

Our Section participates in the National CBA Wills & Estates Section. In addition, our Section participates in the National CBA Real Estate Section. In 2011, I was elected as the Secretary. By tradition, the person occupying that post will advance through the ranks of the executive every second year, to Treasurer, then Vice Chair, then Chair, then Past Chair. So this year I become Treasurer, and therefore felt obliged to resign as Chair of the South Saskatchewan level.

#### Section Activities

On September 27, 2012 Council unanimously approved the formation of a Saskatchewan Branch of SOGIC. Membership in SOGIC is open to any CBA member who wishes to be involved in supporting and promoting the interests of the Saskatchewan LGBTT legal community.

This is the first time SOGIC has had a presence in Saskatchewan and its formation was announced in an article in the winter edition of *BarNotes*. #### Accomplishments:

Attendance was strong throughout the year. We focussed on topics that were relevant and entertaining (insofar as tax is entertaining). Our US real estate ownership talk was overattended and we should have booked a larger space. This topic was of interest to lawyers who do not normally attend the tax section, and may indicate demand by Saskatchewan lawyers for education as to the tax implications of foreign property ownership.

We continue to attract a diverse group of presenters and are excited to be welcoming at least four first-time speakers for next year's line up.

#### Policy Developments:

We set out to amend a troublesome provision of *The Business Corporations Act* (the "Act"), which created uncertainty with respect to stock dividend freezes. A stock dividend freeze involves the issuance of shares in lieu of the payment of a dividend. It is used by tax lawyers and tax accountants to effect certain corporate reorganizations, particularly in closely-held corporations. It is normally used in instances where a person wants to bring a family member into a corporation without triggering adverse tax consequences. In Saskatchewan, however, it is unclear whether such a practice is legally permissible under ss. 41(2) of the Act. We sought to have the Act amended to mirror Alberta and Canada's business corporations acts.
