PRESIDENT'S REPORT

KYLIE HEAD, QC



2013-2014 has been a busy and expanding year for our Branch. I kept a bullet point list of things that I did as President this past year, and the list grew to be seven pages long. Instead of submitting that list, I am going to touch briefly on a number of themes that were important to me this year.

One of my goals as President was to strengthen our Council meetings not only to increase attendance, but to increase engagement between Council members. I am pleased to report that our total annual attendance at Council is up by 30% as compared to last year's attendance. One example of a substantive topic tackled by Council this

year was CBA President Fred Headon hosting a session on the CBA Legal Futures initiative. This session gave Saskatchewan lawyers the opportunity to participate in the Legal Futures consultations.

National released the *Reaching Equal Justice* report in August. Our Branch has been very supportive of National's work on access to justice issues. I represented CBA Saskatchewan at meetings of the new Dean's Forum on Dispute Resolution and the Justice System. This Forum brings together many participants working inside the justice system – the Courts, Saskatchewan Justice, the College of Law, Legal Aid Saskatchewan, The Law Society of Saskatchewan, and Collaborative Lawyers of Saskatchewan, among others – to discuss innovation and access to justice. It is important that Saskatchewan's legal community develops a permanent mechanism to have access to justice deliberations. The CBA must be a strong contributor to those discussions. We are considering setting up a CBA Saskatchewan Access to Justice Committee to support this process. I also was co-sponsored by the CBA and Saskatchewan Justice to attend the American Bar Association (ABA) Equal Justice Conference in Portland, Oregon, to learn about access to justice innovations being pursued by the ABA.

I continue to be particularly interested in the future of rural practice and access to justice in rural Saskatchewan. This year the Branch sponsored a bus trip for law students to visit Moose Jaw and learn what life might be like for them if they were to choose to article there. We hosted a roundtable discussion on Rural Initiatives in our province at the Council Meeting that occurred during the Mid-Winter Meeting (when we knew rural lawyers were more likely to be in attendance). The Membership Chair, Loreley Berra, and I also visited the North East Bar Association to talk to them about what issues they are facing and how the CBA could be of greater use to them. We investigated the use of Skype or similar technology for our Council meetings but the cost is still prohibitive.

Another of my goals that was successfully tackled was to significantly expand Law Day events in our province. I especially wanted to have more balance between the events offered in Regina and Saskatoon, since our events historically tended to be more focused on Saskatoon. I recruited some new committee members from Regina who planned new events in both major centers. A special thanks to all the Law Day Committee members for their hard work.

It is very important that the Branch continues to build on our relationship with students at the College of Law. We need to establish our relevance and value early in the career of a law student. I led or participated in the following events at the College of Law.

- Served as a "cloaker" in the official first year law students welcoming ceremony.
- Brought greetings at the CBA Wine & Cheese Reception, where students meet the Executive and other CBA members and buy their student memberships.
- Brought greetings at our 10th annual CBA Saskatchewan Law Firm Showcase, which highlighted Saskatchewan law firms and the benefits of practicing in Saskatchewan. We work hard to recruit lawyers from throughout Saskatchewan, especially rural lawyers, to attend this event. I previously organized six of the 10 annual Showcases, so it was a highlight of this year for me to attend the event as President.
- Designed and presented at a new first year student orientation session attended by approximately 100 students.
- Spoke on a panel at the College of Law called "Candid Conversations: Succeeding in the Practice of Law".
- Together with the Executive Director, met with representatives of the Law Students' Association and Aboriginal Law Students' Association to get their input on CBA student activities.

Our Mid-Winter Meeting continues to be a success with over 250 lawyers registered for the event and 5 streams of educational sessions provided. My roles at the Mid-Winter included attending the reception with exhibitors, introduction of speakers, hosting the President's Forum and serving as master of ceremonies at the Distinguished Service Awards Luncheon.

It was a busy year for our CBA National Board. Nationally, the CBA is in a time of change, with significant changes to the membership fee structure being implemented this year. The National board has been engaged in a communications audit to determine where CBA National should invest and what matters most to members. The CBA has also been in the media frequently speaking out in defense of the Chief Justice of the Supreme Court of Canada. The National Equality Committee and the National Board are working to develop specific plans to enhance diversity in CBA's leadership.

Also on the National front, I served as a member at large of the Executive Committee of the Public Sector Lawyers Forum. The Executive meets monthly via conference call. My work involved assisting with strategic planning for the Forum. This year we also started a new free monthly CPD teleconference series for public lawyers. From Saskatchewan, I arranged for Brent Cotter, QC, to speak on whether public sector lawyers have higher ethical duties than other lawyers. I was also involved in helping to plan our session for the CLC in St. John's and I will be speaking to public sector lawyers there about the work of the Forum.

Other selected highlights:

- The Branch received a special award recognizing the contributions and support of CBA Saskatchewan to *Right to Know Week* over the past eight years.
- I attended the Manitoba Bar Association Mid-Winter Meeting and Awards Luncheon, and brought greetings at their Council meeting.

- I attended the CBA Alberta's Law Conference and the President's Dinner, and brought greetings to their Council meeting.
- From November to the last Council meeting, the Executive has been discussing Branch Bylaw amendments. Significant amendments to our Bylaws are proposed for our Annual Meeting in June.

I would like to thank the Executive Committee and all our volunteers for making this year so successful. All of your hard work is appreciated. A special thank you also to our very diligent and outstanding staff Brenda, Kayla and Lorraine. You make us all look good!

Distinguished Service Award

The Distinguished Service Award recognizes significant and exceptional contributions and/or achievements by members of CBA Saskatchewan:

- to the legal profession in Saskatchewan;
- or jurisprudence in Saskatchewan or Canada;
- to the law or the development of law in Saskatchewan; or
- involving a significant law-related achievement for the benefit of residents of Saskatchewan.

The 2014 Award was given to Graeme Mitchell, QC, on February 7th, 2014 at the Distinguished Service Award Luncheon held in conjunction with the Branch's annual Mid-Winter Meeting.

Community Service Award

The Community Service Award recognizes the valuable contributions of our members who have demonstrated outstanding dedication, public service and commitment to their respective communities throughout the province. This Award is presented annually at the Branch Annual Meeting, in conjunction with the Law Society of Saskatchewan Annual Meeting. This year the Awards Committee selected Ronald Kruzeniski, QC, as the deserving recipient.

EQUALITY COMMITTEE

BETH BILSON, QC, CHAIR



In 2011, the Equality Committee obtained funding from The Law Society of Saskatchewan, CBA Saskatchewan and The Law Foundation of Saskatchewan to conduct a study on women in the legal profession in Saskatchewan. The study was designed to follow up a research project on this theme carried out in 1990. A survey was conducted with lawyers, law students, law professors and judges in the winter and spring of 2012, which asked respondents to answer a number of standardized questions, and invited them as well to make discursive comments. The responses were analysed by two researchers, Susan Robertson and Liz Quinlan, of the Department of

Sociology at the University of Saskatchewan. The researchers also compared Saskatchewan data with the picture in other jurisdictions. The report from the study was released in October 2013. The Equality Committee is grateful to the Branch for their financial support of this project.

The Chair of the Equality Committee, along with the researchers, presented the results of the study at a meeting for the Women Lawyers' Forum in March 2014.

The Equality Committee recently undertook to provide a regular column on equality issues in *BARNOTES*. The first of these columns summarized the debate over the accreditation of a law school at Trinity Western University in British Columbia.

LEGISLATION AND LAW REFORM COMMITTEE

LORA BANSLEY, CHAIR



The primary mandate of the Legislation and Law Reform Chair is to assist the Branch in pursuing improvements in the law and the administration of justice. Advocacy with respect to legislation and law reform is a key and vital component of the CBA.

The role of the Legislation and Law Reform (LLR) Chair is to monitor, coordinate and assist with the preparation and presentation of Branch submissions on any matter respecting government initiatives made by Sections, Committees and the Branch Executive. Each CBA section designates a LLR representative for its Section. Proposed legislation that is introduced by the government and calls for consultation are circulated

to the Section Chairs and LLR Representatives for review and comment. Reports and papers from the Law Reform Commission are also forwarded to the appropriate sections.

This year I implemented a couple of new approaches to involve more of our membership in LLR activities that were successful. Often requests for consultation by the government are received in months when our sections are not active. For the first time a call for volunteers went out in our monthly eNewsletter, CBA SK Watch, to review and comment on some consultation papers. I was pleased to receive three volunteers through this method. We also used the CBA SK Watch to update members on the progress of Bills through the Legislative Assembly of Saskatchewan and highlight Bills being passed. The first month we tried this, the legislation update received the most hits for members clicking through for more information from the CBA SK Watch eBlast. I recommend continuing to leverage the CBA SK Watch for the Branch's LLR work.

The CBA reviewed requests related to the following legislation in the past year:

- Service Alberta regarding changes to its Business Corporations Act
- Victims Bill of Rights
- Associated Regulations to appropriate sections of The Saskatchewan Employment Act
- The Consumer Protection and Business Practices Act
- The Pooled Registered Pension Plan (Saskatchewan) Act

MEMBERSHIP COMMITTEE REPORT

Membership Numbers

Membership growth continues its battle in the face of the economic climate of the last few years. The CBA has 36,814 active members as of May 27th, 2014.

Saskatchewan has 1152 paid members – which is a slight increase.

As you are aware there are several changes impacting membership and the timing of fee collection such as: the fixed membership year of September 1st to August 31st, the grace period for payment being reduced from 90 days to 60 days, and the portfolio options.

Membership Actions

CBA Saskatchewan was able to join the North East Bar Association for their regular meeting in May. It provided a wonderful opportunity for us to share information about our Branch. More importantly we received valuable feedback about the law school tours, the showcase and section meetings. We hope to be able to address some of those issues in the coming year.

PRO BONO STANDING COMMITTEE

NICOLE SARAUER, CHAIR



CBA Saskatchewan's Pro Bono Committee continued to work to facilitate and promote pro bono work in a variety of ways over the past year. A brief summary of these activities follows:

BARNOTES Articles

A Pro Bono Spotlight piece is regularly submitted for publication in *BARNOTES*. The idea behind this column is to promote pro bono work within the province and also to provide information and resources to lawyers engaged in providing pro bono services.

5th National Pro Bono Conference

The Committee Chair is currently involved in the planning of the 5th National Pro Bono Conference to be held in Regina, Saskatchewan on September 24th-26th, 2014. The Conference will be hosted by Pro Bono Law Saskatchewan in partnership with Canada's other provincial pro bono organizations. It will combine plenary sessions that address major issues and themes related to pro bono culture and practice, and breakout sessions that take a "nuts and bolts" approach to various aspects of developing pro bono projects and delivering pro bono services. This year's Conference will bring together legal practitioners, the judiciary, the voluntary sector and academia from Canada and the United States to share ideas and best practices in pro bono legal services, to forge new access to justice partnerships, and to explore challenging issues that still lie ahead in the pro bono and access to justice sphere.

We are grateful to the CBA for agreeing to sponsor the Welcome Reception, which will be held the evening of September 24th.

The Committee Chair is looking forward to hosting this conference in Saskatchewan for the first time, and is hoping for a large contingent of Saskatchewan legal practitioners, judiciary, academia, and law students who are interested in learning about access to justice initiatives. National Pro Bono Committee

The Committee Chair continues to be involved with the National Pro Bono Committee. Currently the committee is involved in initiatives to reduce barriers to pro bono delivery nationwide such as the lack of insurance for some lawyers in certain jurisdictions. Activity on the National Pro Bono Committee led to the Committee Chair's attendance at the CBA's National Mid-Winter Meeting, held in Ottawa February 22nd and 23rd, 2014 where discussion was had regarding the CBA's *Reaching Equal Justice* report.

The Committee Chair is pleased with the progress seen in promoting access to justice issues and the need for pro bono services over the past year in Saskatchewan. Pro Bono Law Saskatchewan has seen a steady increase of volunteers from Saskatchewan lawyers, which allows Pro Bono Law Saskatchewan to serve more clients each year. This past year, Pro Bono

Events in Partnership with the College of Law

Wine & Cheese Reception

The annual Wine & Cheese Reception was held on September 16th, 2013. At this event the CBA brings greetings to the students, sell memberships, and registers students for the Mentorship program. Members of Council were in attendance to meet and talk with students and the students have expressed that is a highlight of the event. The CBA continues to provide mentorship to law students by matching interested students with volunteering lawyers. The annual "Meet your Match" reception was held on October 23rd, 2013. This year, 89 students registered in the Mentorship Program.

10th Annual CBA Law Firm Showcase

The 10th Annual CBA Law Firm Showcase held at the University of Saskatchewan, College of Law, on November 13th, 2013. Twenty law firms and other legal employers participated in a trade-show type event in the college's library.

The Showcase included small group discussions where students could hear from practitioners on various topics such as rural practice, public practice, in-house corporate counsel, large urban practice and small urban practice.

The event was followed by a reception hosted by the College of Law Career Office.

Mock Interviews

Mock interviews were held throughout the day on January 21st, 2014. This is an opportunity for students to have an interview or select to have a resume critiqued and we were able to provide a number of students with the opportunity to get feedback on both.

Career Forum

Aboriginal Summer Student Hiring Program

The CBA continues to co-ordinate the Aboriginal Law Student Summer Job Program now in its tenth year. The purposes of the program are:

- a) to allow law firms and the legal profession to gain greater insight into Aboriginal culture and issues;
- b) to provide an opportunity for Aboriginal law students early in their legal career to obtain work experience in a law firm; and
- c) to foster opportunities for ongoing relationships to develop between the Aboriginal students and practicing lawyers.

Invitations to participate were sent to firms in September and the deadlines were November 6th to apply and November 22nd to have interviews concluded. Participation remains a challenge and the CBA has been in continuing discussions with the ALSA and the College of Law to address how to ensure the program is meeting the needs of the students and potential employers.

Law Day Activities

This year's Law Day committee included a number of new members who brought enthusiasm and fresh ideas, and provided the opportunity to expand our activities to Regina. The committee is looking forward to continuing the momentum next year and has already started planning a few new things, such as a high school mock mediation demonstration in Regina and the replacement of the Law Day Luncheon with an educational event geared more to the general public.

Law Day Luncheons

One of the activities that the CBA hosted to celebrate the 32nd anniversary of the implementation of the Charter of Rights and Freedoms was the annual Law Day Luncheon in Saskatoon and Regina on April 10th and 11th, 2014. Ian Hanomansing from the CBC was the guest speaker whose speech, "Influencing the Court of Public Opinion" was challenging and thought provoking.

As part of our continuing efforts to provide public education and opportunities to address access to justice issues, we sponsored a group of new immigrants to Regina to attend the luncheon, followed by a tour of the courthouse and police station.

Though the luncheons were well attended, upon reflection of the event and the purpose of Law Day, the decision has been reached to discontinue the annual luncheon and replace it with a more informal event that will be open to the public. The Law Day Committee is in the process of considering what the event will look like and is excited to unveil the details once confirmed.

CBA Mock Trial

Nine teams participated in the 15th annual Mock Trial competition held on April 5th, 2014 at the Saskatoon Court House with a team from Yorkton Regional High School taking home the coveted McKercher Cup. The CBA is grateful for the continued support of this event by the courthouse staff and sponsors and, in particular, the Judges who volunteer their entire Saturday to provide invaluable feedback and insight to the teenagers who participate in this competition.

After the passing of Council's Resolution to amend the Branch Bylaws, the Chair of this Committee and the Executive Director of the Branch prepared the specific Bylaw amendments (which are set out in the black-lined draft of the Bylaws) which amendments are being submitted to the Annual Meeting for approval.

QUEEN'S BENCH BAR JUDICIAL REPORT

MICHELLE OUELLETTE, QC, CHAIR



At the recent Queen's Bench Bar Judicial Council meeting, there were a number of matters of practice discussed of which people should be aware:

Rules Update/Reminder

• The Court wants to remind counsel of the new Rules requiring experts' Reports to be filed 60 days prior to pre-trial - note this confirms that experts need to provide written reports (although the Rules do provide an opportunity for a Pre-trial Conference without experts reports in certain circumstances) in order to allow for cross-examination

prior to trial if appropriate and to ensure that parties are fully apprised of the case they will meet at trial.

- The Court wants to remind counsel, again, of the requirement to file PT Briefs 10 days prior to Pre-trial, failing which the Brief will be stamped "FILED LATE" and costs may be assessed against the Party or the lawyer, depending on the circumstances.
- There have been some concerns raised about the application of the new Summary Judgment rules and in particular some issues regarding the timing for filing materials and so on. The Court's Rules Committee will be looking into this and a number of other matters that have been raised as requiring "tweaking".

Access to Justice Initiative

• The Law Society is currently considering the possibility of authorizing para-legals to make limited appearances in Court. This is driven, of course, by the Access to Justice agenda and the LSS's Access Committee is examining the whole question of the delivery of Legal services by alternate providers. The Court also has a committee looking at the issue.

New Courthouse

- The new Saskatoon Queen's Bench Courthouse is more or less complete. Courtrooms 7 & 8 are in use, the judges are all on floors 3 and 4 and all under 1 roof. The next phase is in action and Courtrooms 1 and 4 are out of action as a result. The last phase involves the middle floor with the Registrar's Office, Sheriff's Office and the Courtrooms on that floor; final completion is expected for September 2015. Currently, Courtroom 7 is a "Smart" Courtroom and is apparently very functional. The Barristers' Lounge will be getting "new" furniture and vending machines.
- The Moose Jaw QB Courthouse will be getting significant renovations including a redesign – as a result of the roof collapse recently. That is expected to be completed by December 2015.

QUEEN'S BENCH BAR JUDICIAL REPORT continued...

Tariff Revision

• The Tariff Revision Project is coming along well. The General Civil and Family Tariffs are being revised separately. We are likely looking at losing the current "Column" format.

Outstanding Judgments

• This is an issue that is on the Chief Justice's radar. Currently, the CJ receives a list from the Registrar of outstanding decisions and he is aiming to have no decisions outstanding for more than 6 months.

Criminal Matters

- Criminal Pre-trials are being instituted in Yorkton, Weyburn, Estevan, Moose Jaw and Swift Current.
- The Court will be passing new Summary Conviction Appeal rules at the next en banc meeting.

McGill Guide to Citation

• There have been some questions raised regarding the proper citation format to be used in Court documents, whether McGill Guide 6th edition, 7th edition or something else altogether. The Law Society is examining the matter, but in addition, the Court of Appeal is currently preparing a Citation Guide that the Queen's Bench Court is likely going to adopt. Although this will be for the Courts' internal use in writing judgments, it would make sense if the Bar were to be advised and use the same format.

BANKRUPTCY & INSOLVENCY SECTION

DAVID GERECKE, CHAIR



Our meetings were reasonably well-attended last year. The meetings tended to have about 9 to 12 in attendance. Meetings are held in Saskatoon.

A number of years ago, in planning our Section meetings, we made a change from a fairly *ad hoc* approach where all or most of the content was legal updates with speakers decided only weeks in advance, to where all or most of our speakers and topics for the year are fully planned in advance. Unfortunately, this does not appear to have had a positive effect on section membership or attendance but

our members have expressed a preference for that recent approach to continue, and we will continue with it.

Clayton Barry of McDougall Gauley LLP is the Vice-Chair of the Section.

The Section enjoys good participation from most senior members of the Saskatoon insolvency bar, as well as several more junior lawyers with an interest in insolvency. The participation of junior lawyers had been rising but has probably flattened out. One factor with membership and participation is probably that Saskatchewan's economy has been strong and there have not been a large number of significant insolvency files in the Province over the past few years.

Several Section members are insolvency professionals who are non-lawyers. The mixture of lawyers and bankruptcy trustees lends itself to lively, informed and practical discussions at luncheon meetings.

For a number of years, the Section has been active in improving practice in the insolvency area. In the past year we did not undertake any independent initiatives, but did use one meeting to provide views to the Law Reform Commission of Saskatchewan on potential reforms to *The Land Contracts (Actions) Act.*

Guest Speaker: Marjorie Simington, Senior Legal Counsel, Water Security Agency On October 1, 2012, the Water Security Agency was created to ensure safety of Saskatchewan drinking water supplies, protect water quality, ensure sustainability of surface and ground water supplies, reduce flood risks and own and manage the province's public policy water management dams and supply channels. This discussion focused on the general and specific responsibilities of the agency, its new legislation, along with its implementation of the 25 Year Saskatchewan Water Security Plan.

• <u>Tour of the Weyburn Enhanced Oil Recovery Project (Tentatively June 15th, 2014)</u>

Weyburn is Canada's first operational CCS project The Weyburn-Midale field is a depleted oil producing region that has been injecting CO2 since 2000 and is the site of the world's largest CO2 storage project. The project involves CO2 capture at a coal gasification plant in Beulah, North Dakota (and as of April 2014 at SaskPower Boundary Dam Power Station), transport by pipeline and use for enhanced oil recovery (EOR) in the Weyburn field. By injecting CO2 into the reservoir, operators have been able to access oil that it knew was there but couldn't recover using conventional drilling. Weyburn is recognized as the world's largest geological CO2 storage project. Global researchers

representing over 30 countries estimate that about 30 million tonnes of CO2 will ultimately be stored during the life of the Weyburn EOR project. That reduction in greenhouse gas emissions is equal to taking nearly 6 million cars off the road for an entire year. This will be a guided tour of the Weyburn Enhanced Oil Recovery Project facilities by Cenovus – the operator of the Weyburn field.

Section Membership

The Saskatchewan Environmental and Resources Law Section has 8 full members and 3 noticeonly members, for a total of 11 members, in the 2013-2014 year.

Legislative & Regulatory Developments

The following legislative and regulatory developments occurred in the 2013-2014 year:

- The Enforcement of Maintenance Orders Act, 1997: Chapter 2 (2014 assented March 12, 2014) with a consequential amendment to The Wildlife Act, 1998.
 - Amends certain definitions, and adds a provision for the suspension of hunting licenses.
- The Fisheries Act (Saskatchewan), 1994: Chapter 3 (2014 assented March 12, 2014)
 - Adds a provision allowing the minister from prohibiting certain people from applying for licenses if the Director of Maintenance Enforcement, pursuant to s.43.04(2) of *The Enforcement of Maintenance Orders Act*, 1997, has so directed.

Case Law Developments

The following environmental and natural resource case law was reported during the 2013 - 2014 year:

1. Buffalo River Dene Nation v. Saskatchewan (Minister of Energy and Resources) 2014 SKQB 69

Natural resources law — Oil and gas — Exploration — Application by First Nation for review of Oil Sands Special Exploratory Permits issued by Minister dismissed — Minister not obliged to consult First Nation, which held right to use lands to which permits applied for traditional purposes, in issuing permits, as permits did not authorize entry onto lands — Permit holder had yet to take steps to obtain right to enter — First Nation not affected by issuance of permits — Crown Minerals Act, s. 19.

Application by the First Nation for judicial review of decisions by the Minister of Energy and Resources, relating to the issuance of Oil Sands Special Exploratory Permits. The Minister issued two such permits to Scott covering areas that included land affected by Treaty 10, to which the First Nation was a successor. Treaty 10 granted the First Nation's members rights to

use lands for traditional purposes, and gave rise to a duty of consultation owing by the Crown to the First Nation. No such consultation had taken place prior the posting of the permits for sale or their issuance to Scott. The Minister was of the opinion the duty to consult did not arise in the circumstances.

HELD: Application dismissed. The Minister's decisions did not engage the duty of consultation. The permits issued to Scott did not authorize Scott to enter onto the lands to which the permits applied. Scott had yet to apply for such authorization.

2. R. v. Nordstrom 2014 SKQB 26

Aboriginal law — Hunting, fishing and logging rights — Hunting, fishing or trapping — Appeal by accused from convictions under Wildlife Act and related regulations dismissed — Accused, First Nations member, contravened law relating to game farms by issuing customers First Nations hunting licences and mislabelling animal parts hunted on farm as animals shot in wild — Regulations requiring licensing and proper labelling aimed and controlling export of animals and preventing spread of disease did not interfere with Aboriginal hunting rights — First Nations bylaws regulating on-reserve game farm did not have extraterritorial application excusing accused from complying with import/export regulations.

Natural resources law — Wildlife — Appeal by accused from convictions under Wildlife Act and related regulations dismissed — Accused, First Nations member, contravened law relating to game farms by issuing customers First Nations hunting licences and mislabelling animal parts hunted on farm as animals shot in wild — Regulations requiring licensing and proper labelling aimed and controlling export of animals and preventing spread of disease did not interfere with Aboriginal hunting rights — First Nations bylaws regulating on-reserve game farm did not have extraterritorial application excusing accused from complying with import/export regulations — Animal parts constituted wildlife — Wildlife Act, ss. 2, 9, 31, 34 — Wild Animal and Plant Protection and Regulation of International and Interprovincial Trade Act, ss. 6, 7, 8, 10, 11, 21, 22.

Appeal by Nordstrom from his convictions and the sentences imposed for 12 offences relating to the operation of his game/ hunt farm, located on the reserve lands of the Poundmaker First Nation. Nordstrom was a member of the First Nation. He stocked elk and white-tailed deer purchased from domestic game farms in and out of Saskatchewan on his farm. He also carried on a hunting guide business, so his customers could either hunt game farm animals or wild animals. His game farm was not provincially licensed, but operated under the authority of Poundmaker bylaws. The province expected such bylaws to hold operators to the same or higher standards as provincial regulations. In 2006, Nordstrom was aware the province was monitoring his compliance with provincial operations and labelling requirements and federal import and export regulations. To prevent authorities from tracing animal parts from those killed his customers back to his farm, Nordstrom issued several of his customers First Nations hunting licences and seals for animals they killed on his farm. He was charged in relation to this practice, as well as in relation to his importation of two white-tailed deer from Alberta onto his farm without an import licence. Fines were imposed on Nordstrom roughly equivalent to the amount he received from his customers in hunt fees. For importing the two deer, total fines of \$5,001 were imposed.

HELD: Appeal allowed in part. Nordstrom's conviction for obstruction was set aside, as there was no evidence he interfered with the execution of a process against lands or goods. His other convictions and the fines imposed were confirmed. The animal parts taken by Nordstrom's customers, including capes, hoods and antlers, constituted wildlife for the purpose of statute. Because it was clear Nordstrom was not operating his farm in accordance with standards equivalent to provincial standards, Nordstrom was not entitled to exemptions from import and export requirements that licensed farm operators enjoyed. Band bylaws governing the operation of his on-reserve farm did not have extraterritorial application. To permit Nordstrom to import and export animals or parts without a license or proper identifying labels would undermine the health objectives of the legislation and regulations, aimed at preventing the spread of animal diseases. Despite the fact it was his clients that exported the animal parts. Nordstrom was a party to their offences by issuing the First Nation hunting licences to import deer in the belief he would not succeed in obtaining the required licences from the province. The provincial regulations did not improperly limit Nordstrom's ability to hunt as a member of a First Nation. Their goal and effect was to regulate the export of wildlife for the province.

3. *R. v. Alsager* 2013 SKCA 129

Natural resources law — Wildlife — Appeal by Alsager from dismissal of his appeal from conviction for exporting wildlife from Saskatchewan without a licence dismissed — Deer were killed by American hunters on game farm — Deer had been unlawfully imported into Saskatchewan — Appellant transported the deer to the US — Appeal court judge did not err by interpreting "domestic game farm animal" in the Domestic Game Farm Animal Regulations as requiring the animal be legally held — Appellant had not met the onus upon him to prove he fell within the exemption created by s. 13(2) of the Captive Wildlife Regulations.

Appeal by Alsager from the dismissal of his appeal from conviction for exporting wildlife from Saskatchewan without a licence. The appellant operated a booking agency for hunters who wanted to hunt wildlife on a licensed domestic game farm the appellant's father operated. The appellant assisted some American hunters to kill nine white-tailed deer and one elk on his father's game farm. The deer had been imported into Saskatchewan in 2002 and 2003 without an export and import licence. As a service to the American hunters, the appellant transported the deer, the elk antlers and the elk hide to the US. Since the deer were not uniquely identified, the appellant would not have been able to obtain an export certificate or licence to export the deer antlers. Exporting white-tailed deer without a licence was prohibited by s. 31(1) of the Wildlife Act unless the exemption in s. 13 of the Captive Wildlife Regulations applied to the appellant. At trial, the appellant argued the deer were domestic game farm animals, not wildlife, such that no export licence or permit was required. He also argued he was exempt because his father held a licence as a domestic game farm operator, and he acted as agent for his father. As a result, the appellant could export domestic game farm animals without a licence. The trial judge found the deer were wildife. Since the deer had been illegally imported into Saskatchewan they were not lawfully held and thus did not meet the definition of domestic game farm animals. Therefore, an export licence was needed to lawfully export the antlers. The appellant also argued it was contrary to s. 7 of the Charter and his right to a fair trial to look to evidence pertaining to events that had occurred in 2002 and 2003, which did not result in a prosecution at that time, and for which defences might have existed. He also challenged the constitutionality of the reverse onus clause created by s. 13(2) of the Captive Wildlife Regulations.

HELD: Appeal dismissed. The summary conviction appeal court judge did not err by interpreting "domestic game farm animal" in the Domestic Game Farm Animal Regulations as

requiring the animal be legally held. No other interpretation accorded with the intention of the legislature to regulate the ingress and egress of captive wildlife to the province. The Domestic Game Farm Animal Regulations imposed a series of obligations on a person operating a domestic game farm. Under the Regulations, it was irrelevant the person who acquired the animal was the holder of a domestic game farm licence. It was the origin of the animal that was controlled. The legislation appropriately read required, but did not make available, an export licence for the exportation of domestic game farm animals not legally held. The summary conviction appeal court judge committed no error of law by sustaining the trial judge's finding the appellant had not met the onus upon him to prove he fell within the exemption created by s. 13(2) of the Captive Wildlife Regulations. The fact someone was not caught or prosecuted did not make the individual's action lawful. The Crown need not prosecute the principal before convicting the party.

Section Activities in Saskatoon

Women Lawyers' Forum North Executive for 2013-2014

The Women Lawyers' Forum (WLF) – North has a small but enthusiastic membership, often joined by those with Roving Section Memberships. Our meetings generally include experienced practitioners and newer members of the Bar. In 2013-2014 we met for four evening meetings. The group has decided that the evening/after-work time generally works

better than noon hour meetings.

Our meetings consisted of the following:

- In October, 2013 we planned a "Speed Mentoring" session in which our experienced members were asked to bring a mentoring tip or two, and our more junior members were to bring a practice question. The format was meant to be a series or rotating 5-minute conversations to facilitate a high degree of one-to-one interaction, but due to an imbalance in attendance that evening, we adjusted the format and had a lively exchange of experience on thriving in practice. We'll revisit the "speed-mentoring" format.
- January's meeting was a viewing and discussion of Sheryl Sandburg's TED talk: "Why we have too few women leaders" and the book inspired by her talk, "Lean In".
- In March we had a thought-provoking presentation by Beth Bilson, QC, Susan Robertson and Elizabeth Quinlan, all of the University of Saskatchewan, and authors of the Report to the Law Society of Saskatchewan, CBA Saskatchewan and The Law Foundation of Saskatchewan on "Women and the Legal Profession in Saskatchewan: National and Historical Comparisons". This was clearly a topic of interest as it was the largest attendance to date.
- At our May meeting, we challenged ourselves to think about the unique talents that women bring to business and the practice of law. Our discussion was lead by two dynamic and successful women: Michele Hollins, QC, National Vice-President of the Canadian Bar Association, and Jennifer Koury, Vice-President Human Resources and Community Engagement, BHP Billiton.

The WLF – North has an ambitious list of potential topics for the 2014-2015 season. While the program has not been finalized we may follow up with a "Lean In debate", meet with law students at the College of Law, look at interdisciplinary practices, consider different practice and fee models, address financial planning for women, explore technology options, share favourite vacation locations, learn about law-related boundaries in social media and talk about women in law... from a male perspective. Our discussions will generally be on topics geared toward women in the legal profession.
