King's Counsel appointments are made by the Cabinet with the Judiciary, the Law Society of Saskatchewan and The Canadian Bar Association, Saskatchewan Branch (CBASK) providing input. The appointments are traditionally announced in December each year. CBASK will be considering eligible members whose names may be put forward to the Minister of Justice. Members of the CBA are invited to submit a nomination for a likely candidate or for themselves to CBASK.

PRE-REQUISITE QUALIFICATIONS

- ✓ Demonstrated superior legal ability;
- ✓ Proof of good character and integrity;
- ✓ No person shall be appointed who has not been entitled for ten years to practice in the superior courts of the United Kingdom of Great Britain and Ireland or of any province or Territory of Canada or for a portion of such period in one and for the remaining portion of such period in another or others of the said courts; and
- ✓ Be a member of The Canadian Bar Association.

FURTHER CONSIDERATIONS

The CBASK King's Council Nominating Committee will also take into account:

- ✓ Contributions as a legal professional to the community;
- ✓ Contributions to the community generally;
- ✓ Contributions through teaching or research; and
- ✓ Contributions to The Canadian Bar Association.
- ✓ The CBA will also, in its recommendations, consider gender, diversity and geography.
